I here by ***release and covenant not-to sue*** Arizona Desert Star Gymnastics LLC, it's officers and /or owners, and any of their employees, staff members, contractors, landlords, or agents and /or members, from ***any and all present and future claims resulting form ordinary negligence on the part of Arizona Desert star Gymnastics LLC or other listed: City of Maricopa, USA STORM, Sequoia Pathway or Stage Stop Market Place*** for property damage, personal injury , or wrongful death, arising as a result of engaging or receiving instruction in gymnastics, tumbling, or any other activities incidental thereto, wherever, whenever, or however the same may occur. ***I hereby voluntarily waive and all claims resulting from ordinary negligence***, both present and future, that may be made by me, my family, estate, heirs, agents, representatives or assigns.

Further I understand that gymnastics, tumbling, and related activities always involve certain risks, including but limited to death, serious neck and spinal injuries resulting in complete or partial paralysis, brain damage, and serious injury to all bones, joints, muscles, and internal organs, and that mats, pits, and other safety equipment and apparatus provided for protection, including the active participation of a coach / teacher who will spot or assist in the performance of certain skills, may be inadequate to prevent serious injury. I am voluntarily allowing my child to participate in this activity with knowledge of the risks involved and hereby agree to accept any and all inherent risks or property damage, personal injury or death.

Member Registration:

TRIAL CLASSES- GYMNASTICS /CHEER ONLY

1. Trials must be pre-registered over the phone.

3. After a trial the potential client has 3 days to decide whether or not to do that specific class. No spot are held with out payments. There is 1 trial per calendar year in each area(Gymnastics/Cheer)

ATTENDANCE

- ENROLLMENT IN OUR PROGRAM IS WITH THE UNDERSTANDING THAT YOUR CHILD HAS A RESERVED CLASS SPACE FOR WHICH YOU MUST PAY FOR REGARDLESS OF YOUR CHILD'S ACTUAL ATTENDANCE.
- There is NO PRO-RATING for missed classes or lessons.
- Parents or guardians are responsible for ensuring that the member uses the reserved space.
- If your child will be absent from a class, please inform our office staff. Also, if you know that your child will not be attending classes for a week or more, please inform us of this as well.
- Unless we receive 30-day notification, we will reserve your child's space in class for the remainder of a session.
- *If, at that point, Desert Star gymnastics, LLC has not been notified of your intentions, your credit card will be continuously billed for the appropriate amount for the month.*
- Your child's un-used space prevents another child from participating in a class.

Please help us maintain ratios and quality of instruction by communicating your intentions as soon as possible.

VIEWING POLICY

Management at Desert Star Gymnastics, LLC welcomes parents, family members, and friends to observe our classes from any of our viewing areas. We **DO** respectfully request that all that are not participating wait in a viewing area, even if the student is waiting for a class to begin. NO child without being a member or a waiver on file is allowed in any of our training areas.

MAKE UPS:

**There is 1 make per a 4-week session, and needs to be made up with in the same session.
There is NO Prorating for missed classes.**

PRIVATE LESSONS:

- Private lessons are to be scheduled with instructor of choice
- \$25 for a 45 minute session is the minimum cost pending which coach and qualifications
- Payments are made directly to the coach
- If a private lesson is scheduled during the facility's (off hours) at least one adult companion
- Preferably a family member **MUST** accompany the student and wait in the lobby during the lesson.

LEVEL ADVANCEMENTS

Will happen when a DSG staff member has completed the skill sheet and participant has performed at recital or meet to the number required by each level.

STUDENT ATTIRE

For safety reasons, BELTS, JEWELRY, TIGHTS WITH FEETIES, DENIM SHORTS, OR ANY OTHER RESTRICTIVE CLOTHING should **NOT** be worn for gymnastics classes. Long hair should be pulled back with a plain elastic band. *Girls* may wear leotards, bodysuits, t-shirts, athletic-type shorts, or sweat shirts/pants. *Boys* may wear athletic-type shorts, t-shirts, or sweat shirts/pants.

STUDENT CONDUCT

Students are expected to remain in the lobby when not participating in class. While participating in class, students should remain with their class and follow the instructor's directions. While on the premises, both inside and outside, students are expected to refrain from vulgar, disrespectful, and destructive behavior. Students are encouraged to show respect towards instructors, fellow classmates, other gymnasts and their personal property, as well as the gymnastics facility and equipment. DSG staff members reserve the right to dismiss students, without refund, for repeated activities that are considered to be disrespectful, disruptive, destructive, or that jeopardizes the safety of oneself or others.

CHILD CARE POLICY

We do not provide a child-care service. When our staff is on duty, they are unable to focus on children other than their current class. Although we try our best, DSG is unable to guarantee the welfare of children left unsupervised. For the safety of your children as well as others, please pick them up promptly after their scheduled class. Repeated late pick-ups AND/OR early drop-offs may result in a sitter's fee [SEE OTHER FEES] being charged to your account. We ask your help to discourage your children from wandering around the outside property. NO CHILD IS ALLOWED TO LEAVE THE AREA WITHOUT A PARENT. Parents will be charged \$10 for anyone later than 10 minutes.

MEDICAL RELEASE

The medical releases give DSG staff members and/or authorized agents permission to render first-aid treatments; and/or obtain emergency AND/OR medical treatment without the worry of negative repercussions.

PUBLICITY POLICY

Desert Star Gymnastics LLC, the Booster Club, and other individuals representing DSG may submit articles, photographs, and advertisements to newspapers and other print media from time to time. We may also make our gym and athletes available to various broadcast media as well. The purpose for providing this information and access is: to promote the individual gymnasts and teams at DSG; provide the community with a better understanding of gymnastics and the role our gym plays in the local and national gymnastics community; to promote the sport of gymnastics; and to promote DSG. We do our best to inform potential members that membership and participation in any of our gymnastics programs at DSG provides permission and approval for these submissions for all the athletes and families involved in any of these gymnastics programs. We also do our best to convey the understanding that participation in any DSG publicity is WITHOUT compensation.

GYM RULES

GENERAL RULES

- Always check bulletin boards for up-to-date information.
- Park in designated areas only. **Please do NOT block driveways and entrances!**
- DO NOT LEAVE VEHICLE UNATTENDED IN DROP-OFF/PICK-UP ZONES.
- Please pay membership dues on time.
- NO pro-rating membership fees.
- Be considerate, drop off and pick up students ON TIME.
- Parents, siblings, and gymnasts waiting for scheduled classes are NOT ALLOWED IN THE GYM AREA unless requested by the instructor.
- Participants should wait quietly in the lobby area for their instructor to call them to class.
- If there are concerns/questions, please direct them privately to the instructor either before or after class. In consideration of the instructors' limited time between classes, if you feel that your concerns/questions may require extended time, please schedule an appointment for a later time/date.
- When class is over, participating gymnasts MUST LEAVE THE GYM AREA AND WAIT IN THE LOBBY. If your child waits longer than 10 minutes, there will be an additional sitter's charge of \$10.
- For safety reasons, we request that students wait INSIDE the building for their after class pick up.
- NO GUM, CANDY, FOOD, OR DRINKS in the gym.
- The ONLY DRINK ALLOWED INTO THE GYM AREA IS WATER...IN SPILL RESISTANT CONAINERS!
- Please, NO running in the lobby area.
- No "horsing" around or "rough housing" in the lobby or while participating in class.
- Be respectful and considerate to others and the gymnastics facility and equipment.
- No swearing, fighting or pushing.

- Remain with your class and instructor while participating in class.
- Ask for permission before leaving your group for an unscheduled interruption (ie: drink or restroom break, etc.)
- Stay in designated areas only.
- Wear appropriate clothing in the gym.
- **Do NOT wander around the grounds, beyond the immediate entrance area of the building.**
- Please do not throw objects.
- Trampoline rules are posted and gymnasts are allowed use only with an instructor.
- Follow these general rules and any other safety rules (implied or otherwise) that may be prescribed as needed by the staff at DSG.

ANY PARTICIPANT WHO REPEATEDLY BREAKS THESE SAFETY RULES, OR IS DISRUPTIVE, OR DISRESPECTFUL, WILL BE ASKED TO TAKE A "TIME OUT" OR ASKED TO CALL HOME TO BE PICKED UP.
